I/We hereby understand and agree to the following rules to qualify for a \$50, 2010 Assessment Credit:

- 1. Tree(s) will be 15-gallon container size or larger.
2. Tree(s) will be purchased and planted between 14 October 2009 and 31 January 2010.
3. Tree(s) will NOT be planted on easements or within 3 feet of property lines.
4. Tree(s) will be viewable from the front lot line and will not be obscured by fences or other structures.
5. Receipts must be submitted along with a photo of the planted tree(s) by 31 January 2010.
6. Shrubs do NOT qualify unless three or more 15-gallon sized trees have already been planted.
7. Tree(s) must be one or more of the following (select one or more):

Hardy Shade Trees*: [] Red Maple [] River Birch [] Drake Elm [] Live Oak

*caution: these trees can become quite large, make sure they have adequate room to grow, and will not interfere with structures when mature

2. All work will be done expeditiously once commenced and will be done in a good workmanlike manner by a licensed contractor or myself.
3. All work will be performed at a time and in a manner to minimize interference and inconvenience to other residents.
4. I/We assume all liability and will be responsible for all damage to other lots and/or common area or injury which may result from performance of this work.
5. I/We will be responsible for the conduct of all persons, agents, contractors, subcontractors and employees who are connected with this work. No contractor signs may be installed or erected on your lot.
6. I/We am/are responsible for complying with and will comply with, all applicable federal, state and local laws, codes, regulations and requirements in connection with this work, and I/We will obtain any necessary governmental permits and approvals for the work.
7. I/We will contact the underground cable locating service, "Call Sunshine", 48 hours prior to digging at 1-800-432-4770. There is "no charge" to the homeowner for their service.
8. The ARC Application to the Association. Decisions by the Association may take up to fifteen (15) business days. I/We will be notified in writing or email when the application is approved or disapproved.
